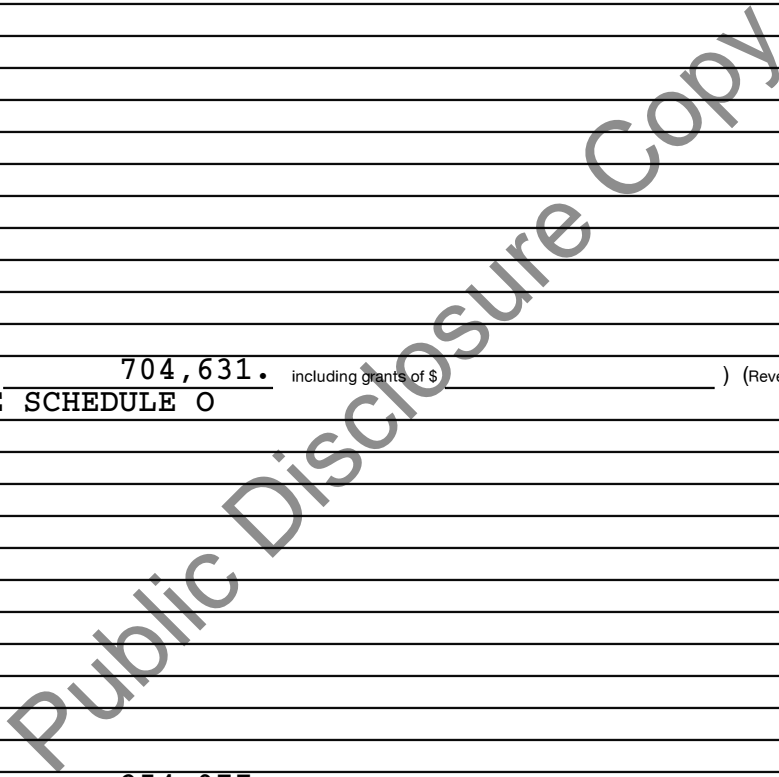

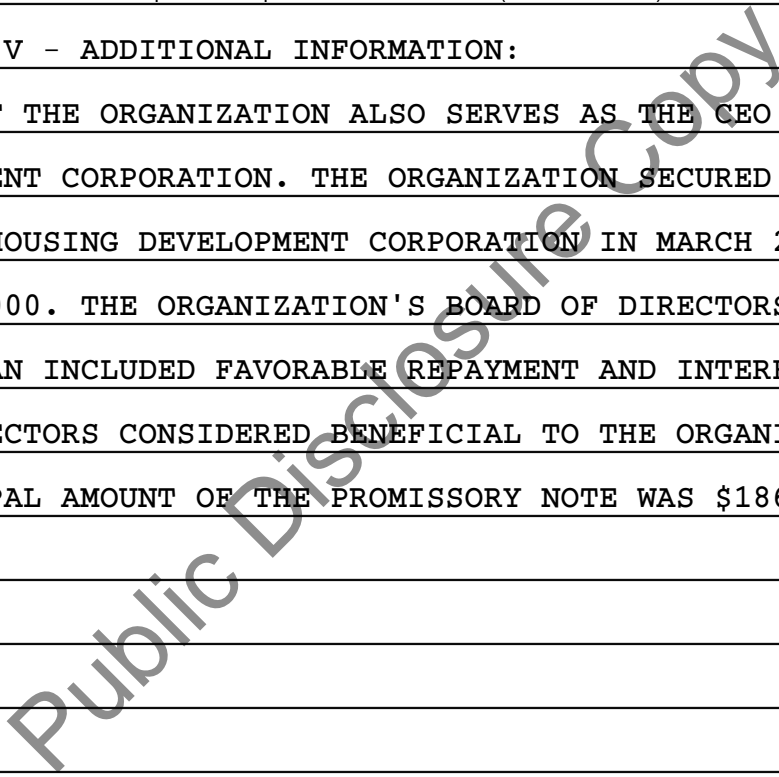

ALSO, A WRITTEN QUESTIONNAIRE IS PROVIDED ANNUALLY TO EACH BOARD MEMBER AND KEY EMPLOYEE TO HELP IDENTIFY ANY POTENTIAL CONFLICTS OF INTEREST.

THE BOARD OF DIRECTORS ELECTS A SUB-COMMITTEE TO HANDLE THE HIRING OF THE PRESIDENT AND CEO AND DETERMINES COMPENSATION BASED ON EXPERIENCE AND SALARY SURVEY RESULTS.
